Note

Dale Standen has played various key roles at both Trent University and the Canadian Canoe Museum. Standen is Professor Emeritus of History at Trent University and has served terms as chair of the Department of History, liaison with Trent's Frost Centre, and the Principal of Lady Eaton College. Standen's research pertains to early colonial history of Canada with a focus on French-Indigenous relations and how museums interpret history. Standen has also held various positions at the Canadian Canoe Museum, including Director on the Board of the Canadian Canoe Museum (ended spring 2004), as a Councilor of the Champlain Society, as President of the French Colonial Historical Society, and as Director of the Board of the Peterborough Historical Society (2018-2019). Standen also assisted in the re-structuring of the Canadian Canoe Museum when they temporarily closed for financial reasons in 2003-2004.

Scope and content

Fonds consists of records related to Dale Standen's involvement at Trent University and the re-structuring of the Canadian Canoe Museum. Records include professional and scholarly correspondence, manuscripts, essays, articles, book reviews, and requested reviews and assessments. Fonds also includes material documenting the Canadian Canoe Museum re-structuring, including committee action plans, meeting minutes, membership correspondence, and progrma files. The fonds is organized into four series: Correspondence and professional files; Trent University materials; Research, publishing, and conference files; and Canadian Canoe Museum files.

Also included are 5 illustrated maps, including of the Lower Great Lakes [ca. 1740], Great Lakes Heartland, French posts, Amerindian nations, and Kanawake and Lake Champlain routes [ca.1726-1748], and of birch bark country [unknown date].

Series 4: Canadian Canoe Museum files

<u>Date</u>: 2000-2009 (creation)

Scope and content: Series consists of material pertaining to Standen's positions on the Board of Directors, Board of Trustees and as the Chair of the Academic Committee at the Canadian Canoe Museum, including re-structuring committee action plans and meeting minutes, governance restructuring and membership correspondence, future educational programs and projects, and partnership proposals from the Hudson's Bay Company. Additionally included are loan agreements and correspondence with the Prince of Wales Northern Heritage Centre (PWNHC) regarding borrowing Birch Bark Canoes, and correspondence with CBC National about filming a documentary with the Canadian Canoe Museum, as well as documents related to John Ralston Saul (His Excellency) visiting the Canadian Canoe Museum.

<u>Arrangement</u>: Material in this series has been reorganized. The file listing starts with the restructuring of the Canadian Canoe Museum in 2003-2004, followed by Hudson's Bay and The Prince of Wales Northern Heritage Centre (PWNHC) partnerships which supported the restructure, followed by programs and events, museum staffing, governance and jobs, and general correspondence.
