ONTARIO TAX REFORM PROPOSALS

Doug McEwen, St. Catharines YMCA, who has been studying the tax reforms, gives this report to O.C.A. Members:-

NOTES FOR CAMPS CONCERNING ONTARIO PROPERTY TAX REFORM PROPOSALS

In the Ontario Budget last May were a set of proposals to reform the property tax system in Ontario. A Commission was appointed and has been holding hearings during the summer and currently across the Province.

A number of organizational camps in Ontario by virtue of the Assessment Act, a Private members Bill or a municipal agreement have been exempt or partially exempt from property tax payments on camp properties. We understand that one of the proposals could have the effect of eliminating these arrangements should legislatic. follow the proposal as outlined - this would affect church camps, Scout & Guide camps, Y.M.C.A.-Y.W.C.A. camps and all other charitable organizations including government operated camps.

At a meeting of the O.C.A. Board of Directors it was agreed that a letter or brief would be submitted on behalf of organized camping expressing concern for those camps affected and pointing out the risk of an attrition in the number of camps providing for youngsters. Similarly the brief will point out that the effect of taxation may affect organization camp's abilities to serve needy youngsters most of all.

It is suggested that while organizations and religious bodies sponsoring camps may be pursuing this matter already, the effect on camps and consequently the clientelle served could be very strongly affected also.

It would be helpful if organizations or camps making submissions to the Commission or their M.P.P. could share this information through the O.C.A.

TO HART M. DEVENNEY

There are those who lead lives of quiet consequence. Hart Devenney was a member of that select group. His broad experience and variety of interests reveal a man whose contribution and inlfuence lay very much in a consistent devotion to young persons.

Although formal education in physical education and recreation was not readily accessible, Hart found his way to Springfield, Mass. where he received his B.Sc. and then on to McGill University to earn his M.A. degree. He next turned to Yale Divinity School for a period of one year. It was at this point in his career that he met Rena Bickerton whom he happily married in 1929.

In 1939 Hart moved to Manitoba to become Director of Urban Youth Centres in that province. The next year found him in the R.C.A.F. auxiliary services which required travel to England, the Middle East, North Africa and Italy. Upon the termination of World War II, he assumed the post of Director for Physical Education and Recreation in the Province of Manitoba where he remained for a very successful decade.

In 1955 Hart moved to Ontario to serve as an inspector and then consultant in Physical Education and Camping for Ontario. After 13 years his attention turned to the managing editorship and assistant directorship of C.A.H.P.E.R. When that organization moved to Ottawa, Hart took on the responsibility of business adminstrator for Kandalore Camps. He was President of the Manitoba Physical Education Association in 1951 and then President of C.A.H.P.E.R. for the 1952-54 term. In 1957 he became the director of The Ontario Camp Leadership Centre at Bark Lake where he remained for many camping summers.

Clearly, Hart M. Devenney was a pioneer who fought through many difficulties and personal trials to gain a breadth of outlook which evoked admiration and commanded respect.

Our sympathy goes out to his wife Rena and their two sons Donald and Richard. We hope they will find comfort in the realization that his many friends and fellow workers hold a special place for a man who has had a remarkable influence on so many.
