Dear Member:

The road traversed by the Ontario Camping Association and by the American Camping Association to reach the destination of an acceptable Study of Sound Camping Practices has been rough. It has been a road of convolutions, potholes, sidetracks and blind endings.

The first faltering steps that finally led to a programme for the visiting and accrediting of camps for children were taken over twenty-five years ago. At that time Ontario camp directors had formed themselves into an association affiliated with the Association of American camp directors. Directors on both sides of the border realized that their Association and the member camps needed the support of a solid foundation to attain public recognition and respect and to provide an adequate measure of security for camping children.

Camp directors are noted for their independence and do not hesitate to express their views and opinions. Early attempts to evolve a satisfactory and acceptable programme of "minimum standards" was beset by fears, discords and frustrations. Committees made little progress.

Eventually direction and incentive were given to the Camping Associations by a Kellogg Foundation grant of \$60,000 (that's right - sixty thousand dollars), for the purpose of conducting a Study on Camping Practices. The basic work was done under the supervision of the University of Indiana, and with the assistance of members of the University staff and student body.

Questionnaires were sent to camp directors; among other things, each director was asked to prepare a comprehensive list, in order of importance, of the factors he considered to be the essentials of sound camping. It took about ten years for the Study to be completed, a Standards visiting programme established, and accredited membership approved.

Before the completion of the Kellogg Foundation Study, camping in Ontario had grown so rapidly that Ontario formed an independent association, and in due time sought to implement a Standards programme. Many of the Ontario directors had worked and contributed to the Kellogg Study. This study, therefore, was used as a starting point for the Ontario Study and evolved with changes and adjustments to meet Ontario's practices and philosophies to the present Study of Camping Practices. Several parts of the Ontario Study subsequently have been incorporated into revised editions of the A.C.A. study.

The Standards Programme highway will never be free from bumps; consistently it will require repairs and intelligent engineering. We believe, however, that it runs in the direction of better camping for children.
