## **ENVIRONMENTAL CONCERNS**

Greetings from the Environmental Concerns
Committee. At the upcoming Directors conference in February the ECC will be presenting
both a session and operate a booth addressing
the questions around "acid rain". What is it?
What can be done about it? and most importantly what can we do about it at camp, how
does it affect us as camps, and how can it be
incorporated into a program. Hope to see you
there.

The Ontario Waste Management Corporation (OWMC) has produced a 15 minute film entitled "Insult Threat and Challenge". It outlines the seriousness and present situation regarding the sources, circumstances, treatment and disposal of industrial waste. Dr. Roger Schauss farmer, economist and professor of environmental studies at York University points out that there is a "hidden cost" in everything we use, and that we haven't yet learned to deal with the industrial waste generated by such common place things as paint, batteries, disinfectant and coffeemate to name a few, let alone the projected wastes of the future. "The unavoidable

legacy of a consumer society".

Fortunately, unlike many other films of this type, "threat insult and challenge" spends much of the time offering some well presented, plain english solutions. The most popular of these seems to be a 3 component system. The first component is high temperature burning, which is used mostly for petro-chemical products. The second is the physical/chemical treatment of inorganic wastes and the third element is "engineered landfill", or the storage of detoxificated waste.

As camp people we have a unique opportunity to educate our campers. Waste management could definitely be incorporated into any camp program. Even though the film itself wouldn't be suitable for camper viewing, it provides much for you as a planner.

The film is available for loan from your public library or from OWMC.

1983 - 1984 REGIONAL DEVELOPMENT PROJECT UPDATE.

Regional Development? Never heard of it? The intention of this article is to update the Membership regarding the 1983 - 1984 OCA Regional Development Project. Funded by The Ministry of Tourism and Recreation (MTR), the project was created to assist the OCA to meet the needs of our membership living in the areas outside of Central Ontario.

In 1982 The MTR's Camp Consultation Service funded two Consultants to visit non-profit camps in the Southern, Northern, and Eastern regions of Ontario.

The Consultants met with members of the OCA Board to discuss three issues concerning this Association. Firstly, the OCA was unknown to many of the non-profit camps visited. Secondly, camps in these regions found it costly to travel and participate in the

staff and professional development workshops generally located in or around the Toronto area. Thirdly, these events often met the needs of those operating camps in Central Ontario, however, regional needs and concerns are felt to be very different.

A proposal was presented to the Board in the Spring of 1983. Upon receipt of financial support of a grant from MTR, the project was to begin. The appointment of a chairperson followed.

In June 1983, MTR, Camping and Outdoor Education Services, hosted two successful staff development workshops held in London and Sudbury. Such events were to be pilot examples of those in a later year to be known as OCA Regional Development Workshops.

Four of the five regions now have Regional Representatives who are prepared to represent their regions on the Regional Development Committee. Sally Moore is the Chairperson. The regions and Representatives are listed below:-

## THIS & THAT

### ONE IN A HUNDRED THOUSAND

A recent court case where an employee - injured while at work - has sued her employer and won, has shocked the insurance industry. The Workmens Compensation Act - where all employees are covered - means the W.C.B. looks after the injured party and recourse cannot be taken by the injured party against another employee or the employer.

EXCEPT - owners or executive officers of a business that carries coverage with the W.C.B. do not have to register with and pay a premium for coverage with the W.C.B. - it is optional. However, should the owners or officers not take the coverage this means they are outside the "ACT". An injured employee - should he or she desire - can opt out of the W.C.B. coverage and sue the owner and/or officers for compensation because of the accident.

This is what happened in this recent court case. The owner of the business was not covered and the injured employee took him to court for compensation and won.

As an owner or officer of a business there are two options to protect oneself. Take the regular coverage offered by the W.C.B. or else have your Insurance Company add Employers Liability coverage to your Public Liability policy. This latter coverage would be added at no extra premium or a very small charge.
