RETAIL SALES TAX

Our December Newsletter article on the 3% Retail Sales Tax has prompted many phone calls from our membership. Here are the facts as we understand them!

Most camps are required to collect sales tax on camper fees on the basis of Ruling 13 (January 12, 1982) amendment to the Retail Sales Act. Here is an exerpt from a 1982 notice the O.C.A. sent to its membership:

ONTARIO SALES TAX ON CAMPER FEES RE-IMPOSED

The temporary exemption of Provincial Sales Tax on camper fees which was given in 1978 has been re-imposed effective January 1, 1982, along with hotels and other establishments providing lodging. It only applies if the fee is in excess of \$50.00

per week and the person stays less than 31 days.

Your Association made an appeal to the Ontario Government back in November 1981 for an exemption to this tax and on April 1, 1982 finally received a reply. The answer was "NO".

You have two choices - one is to charge 3% of your gross camper fee for a period less than 31 days, i.e. four week fee - \$600.00: the tax is \$18.00.

Second choice - you must show on your invoice the amount of fee applicable to meals, counsellor services and lodging. Then charge 7% on the value of lodging. Example:

Meals	\$250.00
Counsellor Service	300.00
Lodging	50.00
7% Sales Tax	3.50
TOTAL	\$603.50

It is very obvious that in this hypothetical case it is much cheaper to use Option No. 2. However, you must be prepared to justify to the Tax Department that your breakdown of fees is correct. If you are unable to do this, they may charge you the balance of tax applicable.

Also, if any of the meals have a value in excess of \$6.00 they are subject to tax of

All these details are given in Ruling 13 under the Retail Sales Tax Act for Ontario, p. 261.

If you are going to use Option No. 2, may we suggest you contact the tax department first with your calculations and obtain their approval. You should make contact with the District Office for your area.

It is our understanding that some camps are exempt from the Sales Tax. We are now trying to clarify with the Government to whom the total exemption applies. We will notify the membership as soon as we have the notice in writing. In the meantime, we suggest you continue to do as you have done since 1982. I wish we could be more specific, but we cannot until we have a ruling.
